Notice is hereby given to all concerned to attend the meeting of the Executive Committee of the Federation to be held at **Bank of India Staff credit Society, RPTS Laxmi Nagar in Nagpur** on 6<sup>th</sup> & 7<sup>th</sup> April, 2018 to transact the following businesses:

1. To consider and confirm the minutes of the Executive Committee meeting held at Indore on 24<sup>th</sup> November, 2017 ;
2. To consider steps to implement the decisions of the highest decision making body (GBM) in Indore;
3. To take stock of measures that have been or are being taken by Gol to implement main recommendations of P. J. Nayak Committee, reform Public Sector Bank's governance and resolve bad loans through IBC, to take stock of inaction on the part of the government to publish list of wilful defaulters, failure of the government to declare wilful default a criminal offence and consider steps to take campaign/ struggle forward;
4. To take stock of inaction on the part of the management of the bank to put the bank on course correction to better governance, ferret out wrongdoing in loan books, strengthen internal audit functions, tighten internal control and supervision, inculcate frugal culture, conduct forensic audit in loan accounts in default with outstanding amount of Rs. 10 crore and above and also in publicity spends. Further to charter action plan for a course corrections;

To take stock of implementation of the decisions taken in 25<sup>th</sup> Triennial General Body Meeting held at Indore and also in extended Office Bearers meeting in Goa calling upon affiliates to tighten loose ends in the organisation, forge connect with members, create awareness on the attacks that are designed to nullify hard earned rights and the move to create exploitative working conditions at workplaces and prepare the rank-and-file for sustained struggle;
6. To fill up vacant posts in the Executive Committee of the Federation by co-option;
7. To take stock of the gap between promise and delivery in the matter of resolution of outstanding issues/ demands and charter course of action for an early settlement/ resolution thereof;
8. To formulate action plan to tackle unethical and illegal practices followed by the management of the bank in the matter of engagement of casual, ad hoc, temporary or daily rated workers and the issue of underpayment of wages to them in the wake of SC judgement;
